### ***When Must I Do What?***

#### **ITEMS TO DO PRIOR TO STARTING HOMESCHOOL**

##### **When do I have to file documents with my school district?**

- \* For a child that has never been in a school situation - Nothing must be done until they turn legal school age (currently age 8).
- \* For a child that has been in a public school situation (not including kindergarten) - The documents must be filed prior to starting homeschooling. \*HSLDA now says this is not required if the child has not turned 8 and as long as the child was formally withdrawn.
- \* To continue homeschooling after filing once, you must file your new documents each year by August 1st to the superintendent or their designated representative of your local school district.

##### **What documents must I file?**

- \* A completed affidavit that has been notarized.
- \* An outline of proposed educational objectives by subject areas for the level of instruction for each student. (If you have a child that has been labeled as special needs, then the program of a special needs child must address the child's needs and be approved by a certified special education teacher or a licensed clinical or certified school psychologist.)
- \* Evidence of the child's immunization and health and dental care OR an exemption due to religious beliefs or a medical exemption. Mandated School Health Services Schedule here:

**Secure an evaluator** that will be willing to do your child's evaluation at the end of the year.

- \* Make sure he/she is in agreement with your philosophy of home education.

#### **WHAT YOU MUST DO DURING THE SCHOOL YEAR**

- \* Keep a contemporaneous log - "A log, made contemporaneously with the instruction, which designates by title the reading material used"  
– Put simply: a listing of the titles of reading materials used and samples of work should be included as part of the portfolio.
- \* Keep track of EITHER the number of hours spent in schooling time (900 hours elementary - 990 hours secondary) OR the days spent in schooling (Must meet 180 days). You are required to complete either the hours requirement OR the days requirement, not both.
- Standardized Testing for students in grades 3, 5, and 8 – results must be presented to your evaluator at your evaluation – List of approved standardized test:

#### **WHAT YOU MUST DO AT THE END OF THE SCHOOL YEAR BY JUNE 30.**

\*Have a qualified evaluator of your choice give written substantiation which states that an appropriate education is occurring. (Act 169 says: Appropriate education shall mean a program consisting of instruction in the required subjects for the time required in this act and in which the student demonstrates sustained progress in the overall program.)

\*Under Act 196 of 2014, you are only required to submit the evaluator's report to the superintendent of your school district by June 30. This is a change from the previous law, which required you to also submit your portfolio and your testing scores from 3rd, 5th, and 8th grade.

## A Few Guidelines for Getting Started:

1. Consider your child's interests, strengths, and weaknesses before determining what curriculum to use.
2. Determine goals and objectives for each child (may want to consider intellectual, physical, spiritual, social – see Luke 2:52).
3. Think about the homeschool approach that best suits your family

4. Order materials – when my children were young we used dollar store workbooks and lots of library books, when I began ordering curriculum I usually ordered from Rainbow Resource <http://www.rainbowresource.com/>
5. Your curriculum is a tool, not a master. Do not feel guilty if you do not finish everything in every book.
6. Plan what your daily and/or weekly schedule will look like. Remember a day can be as long or short as you wish.
7. Be flexible. Do not be a slave to your schedule. Plan a last minute field trip. Go to the park. Have fun and enjoy the freedom of homeschooling.
8. Keep some work samples (or pictures) for your portfolio or memory book. Keep a book list.
9. Be sure to join a support group and/or co-op. It is hard to homeschool alone.
